

Confederate flags at cemeteries: Oregon Commission on Historic Cemeteries position paper

The Oregon Commission on Historic Cemeteries (OCHC) has agreed that historic cemeteries are places where all people should feel welcome and the

presence of the Confederate flag can be threatening.

"OCHC recommends that Confederate flags not be allowed to be flown in historic cemeteries during Memorial Day weekend celebrations, or at any other time. This includes flying the Confederate flag on flagpoles or with small flags placed on individual graves. We do not support allowing flags in historic cemeteries that promote systemic racism, fear, and oppression of anyone. It is extremely important that historic cemeteries are maintained as places where the visitors feel safe and welcome."


