Oregon Museums Association (OMA) is pleased to announce needs-based \$250 scholarships to the 2019 annual conference for students and first-time attendees. If one of the following categories is a fit, please apply.

- 1. **Student.** Must be a student enrolled in a museum studies, history, public history, art history, free-choice learning, or other related program.
- 2. **First-time attendee**. Must be working/volunteering in the museum profession and be a first-time attendee to the OMA Annual Conference.

The scholarship is for travel, lodging, and other expenses. Registration is included, along with an annual OMA membership, if the applicant is not already a member. Successful applicants will be required to write a brief essay about their conference experience. Their essays will be published in the OMA monthly newsletter.

A banner legislative session for arts and culture

Update from the Cultural Advocacy Coalition

It is with deep gratitude that we celebrate the end of the legislative session as of yesterday. We look forward to the Governor signing all of the following bills passed by the

Senate and House this week:

- Extend the Cultural Trust Tax Credit for 6 more years (HB 2164)
- Extend special tax assessments for historic preservation properties for 2 more vears (HB 2164)
- Fund Capital Investment Projects (HB 5030 & HB 5050)- Total of \$5,125,000
- 2019-2021 Budgets for the Cultural Trust and the Oregon Arts Commission have been funded at the Governor's recommended levels (SB 5524)
- Renew the provision to spend cultural trust license plate monies on the marketing and promotion of the Trust (HB 2377)

Also in support of the cultural sector, the legislature provided funding for Oregon Public Broadcasting, and the Oregon Historical Society, long-standing members of the Cultural Advocacy Coalition.

Making historic markers less racist and more accurate: Michigan's example



Rewriting the account of an event that previously relied on a single narrative might involve amplifying voices that weren't originally quoted. It might also mean striking offensive, imprecise, or outdated language. That's what the state of Michigan is now grappling with on a broad scale.

Michigan is speckled with more than 17,000 gold-and-green historical plaques. Like their counterparts across the country, these signs make history plainly visible—but only to the extent that a single paragraph can encompass centuries of nuance, acknowledge several different perspectives, and hold up

over time. It's a tall order. So now the state is taking up the task of telling its own story in a contemporary manner, rewriting the way its historic markers recount the past.
