Oregon Heritage offers free guide to collections

The [Heritage Organization's Guide to Creating and Cleaning Up Collection Information](#) was developed in response to those looking to create a system to preserve and track the information about their collection or those that want to cleanup their systems full of collection information that may be inconsistent or inaccurate with staff/volunteer turnover over time.

2023 survey of archivists available

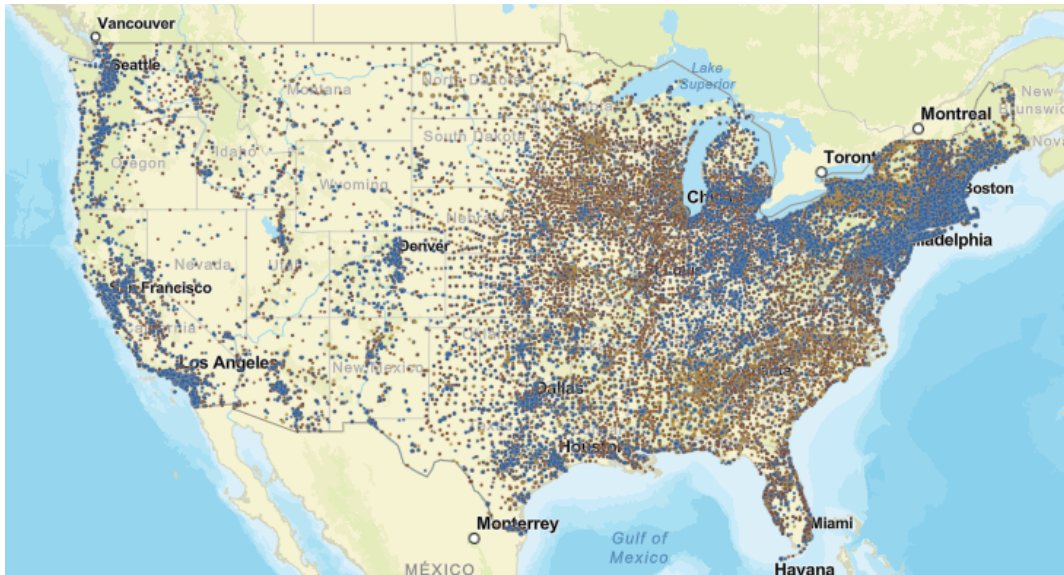
The [2023 All Archivists Survey](#), fielded seventeen years after the original A*CENSUS collected foundational data for the field, provides a measure of how far the field has come in nearly two decades and introduces new or expanded areas of exploration, including sections on diversity, equity, inclusion, and accessibility, community archives, and student loan debt.

Findings include the following:

- The majority (61 percent) of respondents employed full-time make between \$40,000 and \$79,999 annually.
- While diversity, equity, inclusion, and accessibility goals have not yet been achieved in the archives profession, there is encouraging evidence that steps are being taken to reach them.
- The top three challenges community archives face are funding, collection storage space, and generating awareness of the archives.

Researchers develop dataset of US museums, libraries, galleries, and archives



A research team from Louisiana State University compiled and verified a unique dataset, including the georeferences for the majority of US Galleries, Libraries, Archives and Museums (GLAMs). The original data sources included the Institute of Museum and Library Services (IMLS), the National Center for Education Statistics, the Archives RepoData project, and the Department of Defense. After compiling the source data, the project team employed over 35 undergraduate and graduate students to manually verify and update physical location of the GLAMs. The resulting dataset includes nearly 74,000 entries and represents the first known directory of all U.S. GLAM locations.

The dataset is part of the research study *Providing Risk of The Environment's Changing Climate Threats for Galleries, Libraries, Archives & Museums (PROTECCT-GLAM)*. It is freely available for use via the LSU Digital Commons and accessible on the project website. The PROTECCT-GLAM team also provided access to a form for GLAMs to submit feedback and revisions to the dataset which will be updated monthly through 2024 and quarterly thereafter.

Diversity, Equity, Access and Inclusion (DEAI)

Trans-inclusive guidance available for museums, galleries, archives and heritage organizations



In the context of growing uncertainty and anxiety surrounding trans-inclusive practice in the cultural sector, the University of Leicester's (England) Research Centre for Museums and Galleries (RCMG) – working with a team of legal scholars and experts in inclusion, equality and ethics – has developed comprehensive guidance on advancing trans inclusion for museums, galleries, archives and heritage organizations.

The guidance, intended primarily for anyone working with or in museums, galleries, archives and heritage, sets out an ethical framework to support cultural organisations to advance trans inclusion.

New standards released for museums with Native American collections

The School for Advanced Research and the American Alliance of Museums (AAM) released Standards for Museums with Native American Collections. It includes actionable recommendations to help museums clarify and strengthen their roles as stewards. It aims to help institutions provide more meaningful and culturally sensitive interpretation and documentation and includes case studies from institutions exemplifying meaningful collaboration and inclusion.
